**Subject : Invitation to Tender for supply and fixing of Punched Tape Concertina Coil (PTCC) fencing on top of boundary wall of Consulate General Of India in Medan at Jl. Uskup Agung A Sugiopranoto 19, Medan City, North Sumatra 20152**

Sealed bids are invited for supply & fixing of Punched Tape Concertina Coil (PTCC) fencing on boundary wall of Consulate General of India, Medan. Interested parties may submit their sealed tenders to Consul General, Consulate General Of India, Medan at Jl. Uskup Agung A Sugiopranoto 19, Medan City, North Sumatra 20152. The firms are requested to submit their bids in two separate double sealed envelopes. One envelope should clearly mention "Technical Bid" and another envelope "Financial Bid". It may be noted that the price is not to be quoted in the technical bid. It shall only be quoted in financial bid. Non-adherence to this shall be making tender liable for rejection. The sealed envelopes shall be again put in another sealed cover and should be superscribed as "Tenders for supply and fixing of Punched Tape Concertina Coil (PTCC)".

**TERMS AND CONDITIONS**

1 The tender shall be neatly arranged, plain and intelligible. Each page of the tender should be numbered & signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the tender. The conditional tender will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature. Bidders are requested to submit the Technical Bids (Annexure – II) and Financial Bids (Annexure-III) in separate sealed envelopes.

2 To safeguard against a bidder's withdrawing or altering the bid during the bid validity period, Earnest Money Deposit / Bid Security of IDR 2.000.000/- (Indonesian Rupiah Two Million Only) in the form of Account Payee Demand Draft or Fixed Deposit Receipt or Banker's Cheque or Bank Guarantee from any of the Commercial Banks valid for a period of forty-five days beyond the final bid validity period or payment online in an acceptable form must be submitted by the bidder along with the technical bid document. The technical bids without Earnest Money Deposit / Bid Security will be rejected. Earnest Money Deposit / Bid Security of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract. Earnest Money Deposit / Bid Security of unsuccessful bidders during technical evaluation will be returned within 30 days of declaration of results of technical evaluation. Earnest Money Deposit / Bid Security of the successful bidder will be refunded on receipt of performance security. Earnest Money Deposit / Bid Security of the successful bidder will be forfeited in case of withdrawal or modification of the bid during the period of validity or if they are awarded the contract and they fail to sign the contract or fail to furnish the required performance security within the specified period.

3 To ensure due performance of the contract, performance security of an amount equal to 5 percent of the value of the contract in the form of Account Payee Demand Draft or Fixed Deposit Receipt or Banker's Cheque or Bank Guarantee from any of the Commercial Banks valid for a period of sixty days beyond the date of completion of all contractual obligations of

the successful bidder including Workmanship Guarantee / Defect Liability Period (DLP) or payment online in an acceptable form must be submitted by the successful bidder within 21 days of the award of contract. The performance security will be forfeited and credited to the Consulate General of India, Medan's account in the event of a breach of contract by the contractor. It would be refunded to the contractor without interest after the contractor has duly performed and completed all obligations under the contract but not later than 365 days of completion of the Workmanship Guarantee / Defect Liability Period.

4. The bidders shall visit the site before bidding to apprise themselves of the exact requirements relating to the scope of the work.
5. The bidder shall submit documentary evidence in respect of their technical capabilities and experience in providing of similar services.
6. Any tender received by Consulate General of India, Medan after the deadline for submission of tenders will not be accepted/considered.
7. The firms / companies concerned will be fully responsible for the safety and insurance of its employees. All local permissions, if required, need to be taken by the firms.
8. In case of any ambiguity/dispute in the interpretation of any of the clauses in this tender document, Consulate General of India, Medan's interpretation of the clauses shall be final and binding on all parties.
9. If any information furnished by the bidder is found incorrect at a later stage, the firm / company shall be liable to be debarred from tendering. Consulate General of India, Medan reserves the right to verify the particulars furnished by the applicants independently.

**GENERAL CONDITIONS OF CONTRACT**

**1. Prices**

- i. Price quoted by the bidder and agreed to by Consulate General of India, Medan shall be considered final and no price escalation will be permitted thereafter.
- ii. Bidders must quote the price in the format given in Contract price schedule at **Annexure-III** of this document.
- iii. All prices are to be quoted in Indonesian Currency only.
- iv. Payment of 90% of total amount will be paid after successful completion of order and rest 10% after a period of 12 months or 365 days (Defect Liability Period / Workmanship Guarantee Period) from the date of successful completion of work.

**2. Taxes and duties:** The rates quoted (total) should be inclusive of all taxes. However, the bidder has to provide the breakup of the total quoted rate, that is the rates without tax component and taxes separately. (As per the format given in Annexure III)

**3. Force Majure:** Consulate General of India, Medan may consider relaxing the penalty and work requirements, as specified in this document, if and to the extent, that the delay in performance or other failure to perform its obligations under the contract is the result of a Force Majure. Force Majure is defined as an event or effect that cannot reasonably be anticipated such as acts of nature (like earthquake, floods, storms, etc.), acts of states, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises.

**4. Completion of work:** The work is to be completed within forty five (45 days) after award of the work order. Consulate General of India, Medan reserves the right to levy penalty @0.5% of the contract value per day for delay beyond the scheduled period upto maximum of 5% of total contract value.

**5. Workmanship Guarantee / Defect Liability Period:** The successful bidder should give a workmanship guarantee of 12 months for entire work carried out and manufacturer's guarantee for specific period for equipment installed and undertake to repair / replace at no cost to Consulate General of India, Medan during this period.

**SCOPE OF WORK**

Following are the details of work for supply and fixing of PTCC on top of the boundary wall of Consulate General Of India in Medan at Jl. Uskup Agung A Sugiopranoto 19, Medan City, North Sumatra 20152

**1. Minimum specifications:**

1.	Coil Diameter	600 mm
2.	Weight	Each coil with 50 turns/loops should be around 9-10kgs ± 5%. If the turns/loops are less, the weight shall be correspondingly less.
3.	Steel Strip	The Punched Tape should be CR3 grade cold reduced low carbon steel with zinc coating (80gms per sq.mtr.)

4.	Material	Should be high carbon steel
5.	Diameter	Between 2.6mm – 3mm

2. Punched Tape Concertina Coil (PTCC) is to be provided & fixed in position on top of the approximately 235 meters long boundary wall. Concertina coils have to be provided and fixed as running coils installed in the form of single coil. Concertina coil shall be fixed on 'Y' shaped Angles. One Hundred and Twenty (120) 'Y' shaped Angles would be required. The concertina coils shall be fixed to these Angles with the help of u-nails / split pin. These angles will be painted with water resistant / weather shield / anti rusting good quality white color. Apart from this, approximately 705 meters (that is three times the length of boundary wall) of supporting punched tape wire in three straight horizontal lines / wires is required to be fixed on angles.

3. The bidder will be responsible for removal of existing barb wires and angles on the boundary wall of the consulate. The removed existing bard wires and angles shall be returned to the Consulate.
